## OVERVIEW OF BEAR RIVER MENTAL HEALTH BRIGHAM CITY UT

BEAR RIVER MENTAL HEALTH BRIGHAM CITY UT SERVES AS A REGIONAL CENTER DEDICATED TO MENTAL HEALTH ASSESSMENT, TREATMENT, AND SUPPORT. AS PART OF A LARGER NETWORK, IT FOCUSES ON DELIVERING HIGH-QUALITY CARE TO INDIVIDUALS FACING MENTAL HEALTH CHALLENGES. THE CENTER OPERATES WITH A MULTIDISCIPLINARY TEAM OF PROFESSIONALS, INCLUDING PSYCHIATRISTS, PSYCHOLOGISTS, SOCIAL WORKERS, AND COUNSELORS, ALL COMMITTED TO PROMOTING MENTAL WELLNESS WITHIN THE COMMUNITY. THE FACILITY EMPHASIZES EVIDENCE-BASED PRACTICES AND PERSONALIZED TREATMENT PLANS TO ADDRESS A WIDE RANGE OF MENTAL HEALTH CONDITIONS. THIS COMMITMENT ENSURES THAT PATIENTS RECEIVE CARE TAILORED TO THEIR UNIQUE NEEDS, FOSTERING RECOVERY AND RESILIENCE.

## MISSION AND VISION

THE MISSION OF BEAR RIVER MENTAL HEALTH BRIGHAM CITY UT IS TO PROVIDE ACCESSIBLE, EFFECTIVE, AND COMPASSIONATE MENTAL HEALTH SERVICES TO IMPROVE THE QUALITY OF LIFE FOR INDIVIDUALS AND FAMILIES IN THE COMMUNITY. ITS VISION IS TO BE A LEADER IN MENTAL HEALTH CARE BY FOSTERING HOPE, RECOVERY, AND WELLNESS THROUGH INNOVATIVE PROGRAMS AND COMMUNITY PARTNERSHIPS.

## HISTORY AND COMMUNITY ROLE

ESTABLISHED TO MEET THE INCREASING DEMAND FOR MENTAL HEALTH RESOURCES IN NORTHERN UTAH, BEAR RIVER MENTAL HEALTH HAS GROWN INTO A CORNERSTONE OF COMMUNITY HEALTH SERVICES. ITS ROLE EXTENDS BEYOND CLINICAL TREATMENT TO INCLUDE EDUCATION, PREVENTION, AND ADVOCACY EFFORTS AIMED AT REDUCING STIGMA AND ENHANCING PUBLIC UNDERSTANDING OF MENTAL HEALTH ISSUES.

# SERVICES PROVIDED

BEAR RIVER MENTAL HEALTH BRIGHAM CITY UT OFFERS A COMPREHENSIVE RANGE OF MENTAL HEALTH SERVICES DESIGNED TO ADDRESS VARIOUS PSYCHOLOGICAL AND BEHAVIORAL HEALTH NEEDS. THESE SERVICES ARE STRUCTURED TO SUPPORT INDIVIDUALS AT DIFFERENT STAGES OF MENTAL HEALTH CHALLENGES, FROM EARLY INTERVENTION TO LONG-TERM MANAGEMENT.

## OUTPATIENT THERAPY AND COUNSELING

OUTPATIENT SERVICES INCLUDE INDIVIDUAL, GROUP, AND FAMILY THERAPY SESSIONS. LICENSED THERAPISTS UTILIZE COGNITIVE-BEHAVIORAL THERAPY (CBT), DIALECTICAL BEHAVIOR THERAPY (DBT), AND OTHER EVIDENCE-BASED MODALITIES TO TREAT CONDITIONS SUCH AS DEPRESSION, ANXIETY, TRAUMA, AND SUBSTANCE USE DISORDERS.

## PSYCHIATRIC EVALUATION AND MEDICATION MANAGEMENT

PSYCHIATRISTS AT THE CENTER CONDUCT THOROUGH EVALUATIONS TO DIAGNOSE MENTAL HEALTH DISORDERS AND DEVELOP MEDICATION PLANS WHEN APPROPRIATE. REGULAR FOLLOW-UPS ENSURE THAT MEDICATION REGIMENS ARE EFFECTIVE AND ADJUSTED AS NEEDED TO OPTIMIZE PATIENT OUTCOMES.

## CRISIS INTERVENTION SERVICES

RECOGNIZING THE URGENCY OF MENTAL HEALTH CRISES, BEAR RIVER MENTAL HEALTH BRIGHAM CITY UT PROVIDES IMMEDIATE SUPPORT AND INTERVENTION FOR INDIVIDUALS EXPERIENCING ACUTE PSYCHOLOGICAL DISTRESS. THIS INCLUDES 24-HOUR CRISIS RESPONSE AND STABILIZATION SERVICES TO ENSURE SAFETY AND PREVENT HOSPITALIZATION WHEN POSSIBLE.

## CASE MANAGEMENT AND SUPPORT SERVICES

CASE MANAGERS ASSIST CLIENTS IN COORDINATING CARE, ACCESSING COMMUNITY RESOURCES, AND NAVIGATING SOCIAL SERVICES. THESE SUPPORT SERVICES ARE CRUCIAL FOR INDIVIDUALS DEALING WITH COMPLEX CHALLENGES SUCH AS HOMELESSNESS, UNEMPLOYMENT, OR CO-OCCURRING DISORDERS.

## COMMUNITY OUTREACH AND SUPPORT PROGRAMS

BEYOND DIRECT CLINICAL CARE, BEAR RIVER MENTAL HEALTH BRIGHAM CITY UT ACTIVELY ENGAGES IN COMMUNITY OUTREACH INITIATIVES AIMED AT PROMOTING MENTAL HEALTH AWARENESS AND PREVENTION. THESE PROGRAMS ARE DESIGNED TO REDUCE STIGMA AND EDUCATE THE PUBLIC ABOUT MENTAL HEALTH CONDITIONS AND AVAILABLE TREATMENTS.

## **MENTAL HEALTH EDUCATION AND WORKSHOPS**

THE ORGANIZATION REGULARLY HOSTS WORKSHOPS AND SEMINARS FOR SCHOOLS, WORKPLACES, AND COMMUNITY GROUPS. THESE EDUCATIONAL EFFORTS FOCUS ON TOPICS SUCH AS STRESS MANAGEMENT, SUICIDE PREVENTION, AND RECOGNIZING SIGNS OF MENTAL ILLNESS.

## **SUPPORT GROUPS**

PEER-LED AND PROFESSIONALLY FACILITATED SUPPORT GROUPS PROVIDE ONGOING ASSISTANCE FOR INDIVIDUALS COPING WITH SPECIFIC ISSUES SUCH AS GRIEF, ADDICTION RECOVERY, AND CHRONIC MENTAL ILLNESS. THESE GROUPS FOSTER A SENSE OF COMMUNITY AND SHARED EXPERIENCE, WHICH IS VITAL FOR HEALING AND RESILIENCE.

## **COLLABORATIONS WITH LOCAL AGENCIES**

BEAR RIVER MENTAL HEALTH PARTNERS WITH SCHOOLS, LAW ENFORCEMENT, HEALTHCARE PROVIDERS, AND SOCIAL SERVICE AGENCIES TO CREATE A COORDINATED APPROACH TO MENTAL HEALTH CARE. THESE COLLABORATIONS ENHANCE RESOURCE SHARING AND ENSURE COMPREHENSIVE SUPPORT FOR INDIVIDUALS AND FAMILIES.

## **ELIGIBILITY AND ACCESS TO SERVICES**

ACCESSING SERVICES AT BEAR RIVER MENTAL HEALTH BRIGHAM CITY UT INVOLVES A CLEAR AND STRUCTURED PROCESS DESIGNED TO ACCOMMODATE DIVERSE POPULATION NEEDS. THE CENTER STRIVES TO REDUCE BARRIERS AND PROMOTE INCLUSIVITY IN MENTAL HEALTH CARE.

## **WHO CAN ACCESS SERVICES?**

SERVICES ARE AVAILABLE TO RESIDENTS OF BRIGHAM CITY AND THE SURROUNDING BEAR RIVER REGION, INCLUDING CHILDREN, ADOLESCENTS, ADULTS, AND SENIORS. THE CENTER PROVIDES CARE REGARDLESS OF THE INDIVIDUAL'S ABILITY TO PAY, OFFERING SLIDING SCALE FEES AND ASSISTANCE WITH INSURANCE NAVIGATION.

## **INTAKE AND ASSESSMENT PROCESS**

NEW CLIENTS UNDERGO AN INTAKE ASSESSMENT TO DETERMINE THEIR MENTAL HEALTH NEEDS AND APPROPRIATE TREATMENT OPTIONS. THIS EVALUATION INCLUDES CLINICAL INTERVIEWS, PSYCHOLOGICAL TESTING, AND REVIEW OF MEDICAL HISTORY TO CREATE A COMPREHENSIVE CARE PLAN.

## **INSURANCE AND PAYMENT OPTIONS**

BEAR RIVER MENTAL HEALTH ACCEPTS VARIOUS FORMS OF INSURANCE, INCLUDING MEDICAID AND MEDICARE. FOR UNINSURED INDIVIDUALS, THE CENTER OFFERS FINANCIAL ASSISTANCE PROGRAMS TO ENSURE THAT COST DOES NOT IMPEDE ACCESS TO NECESSARY CARE.

## **CONTACT AND LOCATION INFORMATION**

FOR THOSE SEEKING MENTAL HEALTH SERVICES OR MORE INFORMATION ABOUT PROGRAMS, BEAR RIVER MENTAL HEALTH BRIGHAM CITY UT MAINTAINS AN ACCESSIBLE AND WELCOMING FACILITY. THE STAFF IS AVAILABLE TO ASSIST WITH QUESTIONS, SCHEDULING APPOINTMENTS, AND PROVIDING GUIDANCE ON AVAILABLE RESOURCES.

## **FACILITY LOCATION**

THE BRIGHAM CITY OFFICE IS CENTRALLY LOCATED TO SERVE THE SURROUNDING COMMUNITIES, PROVIDING A CONVENIENT ACCESS POINT FOR MENTAL HEALTH CARE IN NORTHERN UTAH.

## **HOW TO REACH BEAR RIVER MENTAL HEALTH**

PROSPECTIVE CLIENTS AND COMMUNITY MEMBERS CAN CONTACT THE CENTER VIA PHONE OR VISIT IN PERSON DURING BUSINESS HOURS. THE STAFF IS TRAINED TO PROVIDE PROMPT RESPONSES AND DIRECT INDIVIDUALS TO THE APPROPRIATE SERVICES EFFICIENTLY.

## **ADDITIONAL RESOURCES**

BEAR RIVER MENTAL HEALTH ALSO OFFERS ONLINE RESOURCES AND INFORMATIONAL MATERIALS TO SUPPORT MENTAL HEALTH EDUCATION AND AWARENESS. THESE RESOURCES COMPLEMENT IN-PERSON SERVICES AND EXTEND THE CENTER'S REACH WITHIN THE COMMUNITY.
