# UNDERSTANDING THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM IN WASHINGTON STATE

THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM WASHINGTON STATE IS PART OF A FEDERAL INITIATIVE AIMED AT REDUCING FOOD INSECURITY BY PROVIDING FINANCIAL ASSISTANCE TO PURCHASE FOOD. WASHINGTON'S IMPLEMENTATION OF SNAP IS ADMINISTERED BY THE DEPARTMENT OF SOCIAL AND HEALTH SERVICES (DSHS) THROUGH ITS ECONOMIC SERVICES ADMINISTRATION. THE PROGRAM HELPS ELIGIBLE RESIDENTS BY ISSUING ELECTRONIC BENEFIT TRANSFER (EBT) CARDS, WHICH FUNCTION MUCH LIKE DEBIT CARDS AND CAN BE USED AT PARTICIPATING GROCERY STORES AND FARMERS MARKETS.

Washington State's SNAP program emphasizes accessibility and community support, offering benefits to diverse populations including families, elderly individuals, and people with disabilities. It is a cornerstone of the state's safety net programs, designed to improve nutrition and health outcomes among vulnerable populations. The supplemental nutrition assistance program washington state also collaborates with local food banks and nonprofit organizations to extend its reach beyond direct benefits.

## ELIGIBILITY REQUIREMENTS FOR SNAP IN WASHINGTON

ELIGIBILITY FOR THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM WASHINGTON STATE DEPENDS ON SEVERAL FACTORS INCLUDING INCOME, HOUSEHOLD SIZE, AND CITIZENSHIP STATUS. THE PROGRAM IS DESIGNED TO ASSIST LOW-INCOME INDIVIDUALS AND FAMILIES WHO MEET SPECIFIC CRITERIA SET BY BOTH FEDERAL AND STATE GUIDELINES.

#### INCOME LIMITS

INCOME LIMITS ARE A PRIMARY CONSIDERATION FOR SNAP ELIGIBILITY. WASHINGTON STATE USES GROSS AND NET INCOME

TESTS TO DETERMINE QUALIFICATION:

- Gross Income Test: Household income before deductions must generally be at or below 130% of the federal poverty level.
- **NET INCOME TEST:** After allowable deductions such as housing costs and child care, net income must not exceed 100% of the federal poverty level.

#### HOUSEHOLD COMPOSITION

The size and composition of the household affect eligibility and benefit amounts. A household typically includes all individuals who live together and purchase and prepare meals together. Special rules apply to certain groups such as students, elderly, and disabled individuals.

#### CITIZENSHIP AND RESIDENCY

APPLICANTS MUST BE U.S. CITIZENS OR MEET QUALIFYING NON-CITIZEN CRITERIA. ADDITIONALLY, RESIDENCY IN WASHINGTON STATE IS REQUIRED TO APPLY FOR SNAP BENEFITS THROUGH THE STATE PROGRAM.

#### HOW TO APPLY FOR SNAP BENEFITS IN WASHINGTON STATE

APPLYING FOR THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM WASHINGTON STATE IS A STREAMLINED PROCESS DESIGNED TO ACCOMMODATE VARIOUS APPLICANT NEEDS. THE WASHINGTON STATE DEPARTMENT OF SOCIAL AND HEALTH SERVICES PROVIDES MULTIPLE APPLICATION METHODS TO ENSURE ACCESSIBILITY.

#### APPLICATION METHODS

- ONLINE: APPLICANTS CAN SUBMIT THEIR APPLICATION VIA THE WASHINGTON CONNECTION WEBSITE, WHICH OFFERS A USER-FRIENDLY INTERFACE.
- IN-PERSON: APPLICATIONS CAN BE SUBMITTED AT LOCAL COMMUNITY SERVICES OFFICES ACROSS THE STATE.
- BY MAIL OR FAX: PAPER APPLICATIONS ARE AVAILABLE AND CAN BE MAILED OR FAXED TO THE APPROPRIATE OFFICE.
- PHONE: APPLICANTS CAN CALL DSHS FOR ASSISTANCE OR TO COMPLETE APPLICATIONS OVER THE PHONE.

### REQUIRED DOCUMENTATION

APPLICANTS MUST PROVIDE DOCUMENTATION TO VERIFY IDENTITY, INCOME, RESIDENCY, AND EXPENSES. COMMON DOCUMENTS INCLUDE PAY STUBS, UTILITY BILLS, RENTAL AGREEMENTS, AND IDENTIFICATION CARDS. PROVIDING COMPLETE AND ACCURATE INFORMATION HELPS EXPEDITE THE APPLICATION PROCESS.

### BENEFIT AMOUNTS AND HOW THEY ARE CALCULATED

THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM WASHINGTON STATE CALCULATES BENEFIT AMOUNTS BASED ON

HOUSEHOLD SIZE, INCOME, AND ALLOWABLE EXPENSES. THESE BENEFITS ARE INTENDED TO SUPPLEMENT FOOD BUDGETS AND IMPROVE ACCESS TO NUTRITIOUS MEALS.

#### CALCULATION FACTORS

- HOUSEHOLD INCOME: BOTH EARNED AND UNEARNED INCOME ARE CONSIDERED.
- ALLOWABLE DEDUCTIONS: DEDUCTIONS MAY INCLUDE HOUSING COSTS, CHILD CARE EXPENSES, MEDICAL EXPENSES FOR ELDERLY OR DISABLED MEMBERS, AND STANDARD DEDUCTIONS.
- MAXIMUM ALLOTMENTS: BASED ON USDA GUIDELINES, MAXIMUM BENEFIT AMOUNTS VARY BY HOUSEHOLD SIZE.

#### EXAMPLE OF BENEFIT CALCULATION

FOR ILLUSTRATIVE PURPOSES, A HOUSEHOLD WITH A NET MONTHLY INCOME OF \$1,000 AND THREE MEMBERS MIGHT QUALIFY FOR A MAXIMUM MONTHLY BENEFIT AMOUNT NEAR THE USDA MAXIMUM ALLOTMENT FOR THAT HOUSEHOLD SIZE, MINUS 30% OF NET INCOME, WHICH IS THE STANDARD CONTRIBUTION EXPECTED FROM THE HOUSEHOLD TOWARD FOOD COSTS.

### USING SNAP BENEFITS IN WASHINGTON STATE

Once approved, recipients receive benefits through an EBT card, which can be used to purchase eligible food items at authorized retailers statewide. The supplemental nutrition assistance program washington state ensures that beneficiaries have convenient access to nutritious food options.

#### **ELIGIBLE FOOD ITEMS**

SNAP BENEFITS CAN BE USED TO BUY A WIDE RANGE OF FOOD PRODUCTS, INCLUDING:

- FRUITS AND VEGETABLES
- MEAT, POULTRY, AND FISH
- Dairy products
- Breads and Cereals
- SEEDS AND PLANTS TO GROW FOOD

Non-food items, alcohol, tobacco, vitamins, and hot prepared foods are excluded from SNAP purchases.

#### WHERE TO USE SNAP BENEFITS

Washington State has numerous authorized retailers including major grocery chains, local markets, and some farmers markets where SNAP benefits are accepted. The state actively encourages using benefits at farmers markets to promote fresh and local produce consumption.

#### ADDITIONAL RESOURCES AND SUPPORT SERVICES

THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM WASHINGTON STATE IS SUPPORTED BY A NETWORK OF RESOURCES DESIGNED TO ENHANCE FOOD SECURITY AND NUTRITIONAL EDUCATION. THESE ADDITIONAL PROGRAMS AND SERVICES COMPLEMENT SNAP BENEFITS FOR ELIGIBLE RESIDENTS.

#### NUTRITION EDUCATION

Washington offers nutrition education programs aimed at helping SNAP recipients make healthier food choices and improve cooking skills. These programs often partner with community organizations and health departments.

#### OTHER FOOD ASSISTANCE PROGRAMS

- Women, Infants, and Children (WIC): Provides supplemental foods and nutrition counseling for pregnant women and young children.
- FOOD BANKS AND PANTRIES: LOCAL FOOD BANKS PROVIDE EMERGENCY FOOD SUPPLIES AND OFTEN COLLABORATE WITH SNAP outreach efforts.
- Senior Farmers Market Nutrition Program: Offers additional vouchers to eligible seniors for purchasing fresh produce.

#### CUSTOMER SUPPORT AND ADVOCACY

DSHS provides customer service to assist with application questions, benefits management, and problem resolution. Advocacy groups also support SNAP recipients in navigating the system and accessing additional services.

THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP) IN WASHINGTON STATE PROVIDES ELIGIBLE LOW-INCOME INDIVIDUALS AND FAMILIES WITH FINANCIAL ASSISTANCE TO PURCHASE NUTRITIOUS FOOD. IT HELPS IMPROVE FOOD SECURITY AND PROMOTES HEALTHY EATING.

#### HOW CAN LAPPLY FOR SNAP BENEFITS IN WASHINGTON STATE?

YOU CAN APPLY FOR SNAP BENEFITS IN WASHINGTON STATE ONLINE THROUGH THE WASHINGTON CONNECTION WEBSITE, BY MAIL, OR IN PERSON AT YOUR LOCAL DEPARTMENT OF SOCIAL AND HEALTH SERVICES (DSHS) OFFICE.

## WHAT ARE THE ELIGIBILITY REQUIREMENTS FOR SNAP IN WASHINGTON STATE?

ELIGIBILITY FOR SNAP IN WASHINGTON STATE DEPENDS ON FACTORS SUCH AS HOUSEHOLD INCOME, SIZE, EXPENSES, CITIZENSHIP STATUS, AND WORK REQUIREMENTS. GENERALLY, YOUR INCOME MUST BE BELOW A CERTAIN THRESHOLD BASED ON THE FEDERAL POVERTY LEVEL.

# HOW MUCH FINANCIAL ASSISTANCE CAN I RECEIVE FROM SNAP IN WASHINGTON STATE?

THE AMOUNT OF SNAP BENEFITS YOU RECEIVE IN WASHINGTON STATE VARIES BASED ON YOUR HOUSEHOLD SIZE, INCOME, AND ALLOWABLE EXPENSES. THE AVERAGE MONTHLY BENEFIT AIMS TO SUPPLEMENT FOOD PURCHASES BUT DOES NOT COVER ALL FOOD COSTS.

#### CAN COLLEGE STUDENTS QUALIFY FOR SNAP BENEFITS IN WASHINGTON STATE?

COLLEGE STUDENTS IN WASHINGTON STATE MAY QUALIFY FOR SNAP IF THEY MEET SPECIFIC CRITERIA, SUCH AS WORKING AT LEAST 20 HOURS PER WEEK, RECEIVING CERTAIN TYPES OF PUBLIC ASSISTANCE, OR HAVING DEPENDENT CHILDREN.

#### ARE SNAP BENEFITS ACCEPTED AT FARMERS MARKETS IN WASHINGTON STATE?

YES, MANY FARMERS MARKETS IN WASHINGTON STATE ACCEPT SNAP BENEFITS THROUGH THE ELECTRONIC BENEFIT TRANSFER (EBT) SYSTEM, ALLOWING RECIPIENTS TO PURCHASE FRESH FRUITS AND VEGETABLES DIRECTLY FROM LOCAL FARMERS.

# HOW HAS THE COVID-19 PANDEMIC AFFECTED SNAP BENEFITS IN WASHINGTON STATE?

DURING THE COVID-19 PANDEMIC, WASHINGTON STATE INCREASED SNAP BENEFITS TEMPORARILY AND EXPANDED ELIGIBILITY TO HELP MORE RESIDENTS FACING FOOD INSECURITY. SOME OF THESE EMERGENCY MEASURES HAVE SINCE BEEN PHASED OUT, BUT ONGOING SUPPORT REMAINS AVAILABLE.

To help alleviate this problem, the U.S. Department of Agriculture (USDA) administers a number of nutrition assistance programs designed to improve access to healthy foods for low-income individuals and households. The largest of these programs is the Supplemental Nutrition Assistance Program (SNAP), formerly called the Food Stamp Program, which today serves more than 46 million Americans with a program cost in excess of \$75 billion annually. The goals of SNAP include raising the level of nutrition among low-income households and maintaining adequate levels of nutrition by increasing the food purchasing power of low-income families. In response to questions about whether there are different ways to define the adequacy of SNAP allotments consistent with the program goals of improving food security and access to a healthy diet, USDA's Food and Nutrition Service (FNS) asked the Institute of Medicine (IOM) to conduct a study to examine the feasibility of defining the adequacy of SNAP allotments, specifically: the feasibility of establishing an objective, evidence-based, science-driven definition of the adequacy of SNAP allotments consistent with the program goals of improving food security and access to a healthy diet, as well as other relevant

dimensions of adequacy; and data and analyses needed to support an evidence-based assessment of the adequacy of SNAP allotments. Supplemental Nutrition Assistance Program: Examining the Evidence to Define Benefit Adequacy reviews the current evidence, including the peer-reviewed published literature and peer-reviewed government reports. Although not given equal weight with peer-reviewed publications, some non-peer-reviewed publications from nongovernmental organizations and stakeholder groups also were considered because they provided additional insight into the behavioral aspects of participation in nutrition assistance programs. In addition to its evidence review, the committee held a data gathering workshop that tapped a range of expertise relevant to its task.
