DEMONSTRATED COMMITMENT TO FAMILY MEDICINE AND PRIMARY CARE IS HIGHLY VALUED. CANDIDATES SHOULD ALSO POSSESS STRONG COMMUNICATION SKILLS, PROFESSIONALISM, AND THE ABILITY TO WORK COLLABORATIVELY.

APPLICATION COMPONENTS

THE APPLICATION PACKAGE TYPICALLY INCLUDES:

- ERAS (ELECTRONIC RESIDENCY APPLICATION SERVICE) APPLICATION FORM
- MEDICAL SCHOOL TRANSCRIPTS
- PERSONAL STATEMENT OUTLINING CAREER GOALS AND INTEREST IN FAMILY MEDICINE
- LETTERS OF RECOMMENDATION, PREFERABLY FROM FAMILY MEDICINE FACULTY OR PRECEPTORS
- USMLE OR COMLEX SCORE REPORTS
- CURRICULUM VITAE (CV)

STRONG LETTERS OF RECOMMENDATION AND A WELL-CRAFTED PERSONAL STATEMENT CAN SIGNIFICANTLY ENHANCE AN APPLICANT'S PROFILE.

INTERVIEW PROCESS

SELECTED CANDIDATES ARE INVITED FOR INTERVIEWS, WHICH ASSESS CLINICAL KNOWLEDGE, INTERPERSONAL SKILLS, AND FIT WITH THE RESIDENCY CULTURE. INTERVIEWS MAY INCLUDE MULTIPLE FORMATS SUCH AS ONE-ON-ONE DISCUSSIONS, PANEL INTERVIEWS, AND SCENARIO-BASED QUESTIONS. APPLICANTS ARE EVALUATED ON THEIR MOTIVATION, ETHICAL STANDARDS, AND ABILITY TO THRIVE IN A COLLABORATIVE HEALTHCARE ENVIRONMENT.

RESIDENT LIFE AND SUPPORT
